IN THE LOBBY AND TERRACE OF THE CLARA SHORTRIDGE FOLTZ CRIMINAL JUSTICE CENTER IS A SERIES OF ARTWORKS CREATED BY VISUAL ARTIST SUSAN SCHWARTZENBERG CHRONICLING CLARA SHORTRIDGE FOLTZ'S LIFE AND IDEAS. FOLTZ WAS THE FIRST WOMAN LAWYER IN CALIFORNIA, THE FIRST

WOMAN TO SERVE AS A DEPUTY DISTRICT ATTORNEY IN LOS ANGELES COUNTY AND HER ADVOCACY LED TO THE CREATION OF A PUBLIC DEFENDER SYSTEM IN EACH STATE. SCHWARTZENBERG'S GLASSWORKS, TAPESTRIES AND BENCHES COMPRISE A COMMEMORATION, LAYERING DETAILS OF FOLTZ'S LIFE AND LEGACY WITHIN THE EXPERIENCE OF MOVING THROUGH THE BUILDING.
